ELECTION BY THE MANAGER FOR BASE FEE AND VARIABLE FEE TO BE PAID BY WAY OF CASH AND UNITS IN HUI XIAN REAL ESTATE INVESTMENT TRUST

On 11 January 2016, the Manager notified the Trustee in writing of its election for the Base Fee and the Variable Fee for the year ending 31 December 2016 to be paid to the Manager in the form of cash as to 30% and in the form of Units as to 70%.

Pursuant to the Trust Deed, the Manager is entitled to make an election for the payment of the Base Fee and the Variable Fee, in respect of any real estate of Hui Xian REIT for the period after 31 December 2011, in the form of cash and/or Units. The Trust Deed also provides that the Manager shall make such election, including (if applicable) the respective percentages of each of the Base Fee and the Variable Fee to be paid in cash and in Units, annually on or before 15 January of each year by way of notice in writing to the Trustee and an announcement to the Unitholders.

In accordance with the terms of the Trust Deed, on 11 January 2016, the Manager notified the Trustee in writing of the Manager's election for the Base Fee and the Variable Fee, in respect of the real estates of Hui Xian REIT for the year ending 31 December 2016, to be paid to the Manager in the form of cash as to 30% and in the form of Units as to 70%. Such election was approved by the board of directors of the Manager (the "**Board**") on 11 January 2016.

Under the Trust Deed, such election is irrevocable during the calendar year in respect of which it was made. In the event that the Manager fails to make such an election in any calendar year, the most recent valid election made by the Manager in a prior calendar year shall apply.

This announcement is made pursuant to Clause 14.1 of the Trust Deed.

DEFINITIONS

In this announcement, unless the context requires otherwise, the following terms shall have the following meanings:

“Variable Fee”

the variable fee payable to the Manager pursuant to the Trust Deed in respect of each real estate of Hui Xian REIT, which amount is equal to 3% per annum of the net property income of such real estate for that financial year (before deduction therefrom of the Variable Fee and, where the Property Manager is a subsidiary of the Manager, the Property Manager’s fee), provided however that in respect of Oriental Plaza, and if the Manager so elects, any other real estate(s) of Hui Xian REIT subsequently acquired after Oriental Plaza, and for so long as the Property Manager is a wholly-owned subsidiary of the Manager and with effect from the date on which the Property Manager is appointed or the date of such election by the Manager, whichever is later, such 3% rate shall be split into 2 portions comprising a Variable Fee payable to the Manager which is equal to 2% per annum, and a Property Manager’s fee payable to the Property Manager which is equal to 1% per annum, of the net property income of the relevant real estate (before deduction therefrom of the Variable Fee and such Property Manager’s fee)
